## **Offer document related to Luci Intressenter's cash offer to the shareholders of LightLab published**

On November 6, 2019, Luci Intressenter AB ("Luci Intressenter") announced a public offer to the shareholders of LightLab Sweden AB (publ) ("LightLab") to tender all their shares in LightLab to Luci Intressenter at a price of SEK 5.00 in cash per share (the "Offer").

Luci Intressenter holds, via Gunnar Dellner, Östersjöstiftelsen och Gålöstiftelsen, a total of 14,237,963 B shares (54.37 per cent). In addition, the bidders have received indications from a number of shareholders that intends to accept the Offer, amounting to at least 1,441,710 B shares (5.51 per cent).
